OFFICIAL CALL

Party Canvass Washington County Republican Committee of the Republican Party of Virginia

As Chairman of the Washington County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Lindsey J. Holman, do hereby issue this call for a Party Canvass to be held at the Washington County Government Center, 1 Government Center, Abingdon, VA 24210, from 11 a.m. to 2 p.m. local time on March 26th, 2022, for the following purposes:

- 1. To elect a unit chairman and committee members;
- 2. Electing up to 780 Delegates and an equal number of Alternates to the Ninth Congressional District Republican Convention, to be held on Saturday, April 23, 2022 at the Wytheville Meeting Center, 333 Community Blvd., Wytheville, VA 24382, or its alternate site, beginning at 10:00 a.m. (with registration from 8:30 a.m. to 10:15 a.m.) for the purposes of:
 - a. electing a District Chairman, and
 - b. the transaction of other business as may properly come before the Convention. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes cast for Governor and President at their last election, so that Washington County is entitled to <u>156</u> Delegate Votes Delegate Votes.

Qualifications for Participation

All legal and qualified voters of Washington County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Voters may be required to produce personal identification such as a valid photo ID that is acceptable for voting purposes in order to participate.

Filing Requirements

Candidates for election for Unit Chairman, Members of the Washington County Republican Committee, or as a delegate or alternate delegate to the Ninth Congressional District Republican Convention at said party canvass shall file a written statement by mail or in person, to Lindsey J. Holman, 17173 Stella Drive, Abingdon, VA. 24211, which must be received not later than February 28th, 2022, at 5:00 p.m. and accompanied by any fees required. Postmarks shall not govern.

- Unit Chairman \$50 filing fee.
- Unit Committee Members
- Delegate/Alternate Delegate to the Ninth District Republican Convention \$ 10.00 registration fee (MANDATORY).

<u>Uncontested Offices/Cancellation of Party Canvass</u>

If no more than one candidate properly files for election to any office to be voted upon at the mass party canvass, that candidate will be declared elected. If fewer than the maximum number of unit committee members that Washington County Republican Committee has established prefile, all properly pre-filed candidates shall be declared elected to the applicable unit committee membership position. If fewer than the maximum number of Delegates that Washington County is entitled to at any District convention pre-file, all properly pre-filed candidates shall be declared elected. If there are no contested offices to be voted upon at the party canvass, then no party canvass will be held.

Registration Fees for Party Canvass & Convention

There will be no fee to participate in the Washington County Republican Committee Party Canvass.

There is a MANDATORY registration fee of \$10.00 for each delegate/alternate delegate elected to the Ninth Congressional District Republican Convention. Fees are requested to be paid at the time of filing for election as a Delegate. Please make checks payable to the Washington County Republican Committee, which will forward the registration fee to the Ninth Congressional District Republican Convention.
