OFFICIAL CALL

Mass Meeting Cumberland County Republican Committee of the Republican Party of Virginia

As Unit Chair of the Cumberland County Republican Committee, and pursuant to the Plan of Organization of the Republican Party of Virginia, and as recommended and directed by the Committee, I, Glenn Mozingo, do hereby issue this call for a Mass Meeting to be held at Center Presbyterian Church 1542 Anderson Highway, Cumberland, VA 23040 starting at 6:45 PM ET on March 22, 2023, for the following purposes:

1. Electing as many as 115 delegates and an equal number of alternates to the House District 56 Convention to be held:

May 20, 2023, at 2:00 PM ET Cumberland High School 15 School Road Cumberland, VA 23040 OR

An alternate site if necessary for the following purposes:

- a) Election of Republican Nominee for the Virginia House of Delegates 56th District, and
- b) Transaction of such other business as may properly come before the Convention.
- 2. Electing as many as 115 delegates and an equal number of alternates to the Senate District 10 Convention to be held:

May 6, 2023, at 10 AM ET Buckingham County High School 78 Knights Road Buckingham, VA 23921 OR

An alternate site if necessary for the following purposes:

- a) Election of Republican Nominee for the Virginia Senate 10th District, and
- b) Transaction of such other business as may properly come before the Convention.

Qualifications for Participation

All legal and qualified voters of Cumberland County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in this Mass Meeting, subject to the provisions in Article I of the Plan of Organization of the Republican Party of Virginia.

Mass Meeting participants must present one of the forms of identification listed in §24.2-643 of the Code of Virginia to participate. Included are a valid Virginia driver's license, a valid United States passport, or any other photo identification issued by the Commonwealth, one of its political subdivisions or the United States. Also included are any valid student identification card containing a photograph of the voter and issued by any institution of higher education located in the Commonwealth or any private school located in the Commonwealth, or any valid employee identification card containing a photograph of the voter issued by an employer of the voter in the ordinary course of the employer's business.

Registration Fee

There will be no registration fee to participate in the Mass Meeting.

Pre-Filing Requirements

Individuals may file as a Cumberland County Republican Committee Delegate or Alternate to the House District 56 Convention using the official form attached to this Call.

Individuals may file as a Cumberland County Republican Committee Delegate or Alternate to the Senate District 10 Convention using the official form attached to this Call.

All forms submitted to the unit must be signed by the prospective Delegate.

Pre-filed Delegate forms will be accepted in person, by email, and by U.S. Postal mail no later than 6 PM ET, March 15, 2023. Email submissions are to be sent to fgmozingo@verizon.net. Pre-filed Delegate forms submitted by U.S. Postal Mail are to be mailed to Glenn Mozingo, P.O. Box 15, Cumberland, VA 23040. Pre-filed forms submitted in person may be delivered to Clifton White, Secretary, or Glenn Mozingo, Chair. Postmarks will not govern, and it is the responsibility of prospective delegates to confirm that their forms have been received.

Delegates and Alternates to both conventions are asked to pay a voluntary fee. Checks for voluntary fees should be made payable to the Cumberland County Republican Committee.

Military Members as Delegates

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected, but shall be declared delegates pursuant to Article VIII, Section H. of the Plan of Organization of the Republican Party of Virginia.

Military Member Delegates or Alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within their unit delegation according to candidate preference ballots. Instructions regarding the casting of candidate preference ballots are available in the Call for the Convention, which is available on the website of the Republican Party of Virginia.

Meeting Cancellation

In the event filings for committee Delegates and Alternates to both conventions do not exceed the specified limits, the meeting shall be cancelled.
