#### **Party Canvass**

# Wise county/City of Norton Republican Committee Of the Republican Party of Virginia

As Chairman of the Wise County/City of Norton Republican committee, and pursuant to the Plan of Organization and as recommended and directed by the committee, I, Kimberly Mullins, do hereby issue this call for a Party Canvass to be held at Central High School, 5000 Warrior Drive, Wise, VA 24293, on May 6, 2023, 9:00AM – 4:00PM, for the following purposes:

- 1. To elect a Republican nominee for Sheriff, Clerk of Circuit Court, Commissioner of Revenue, Treasurer, Commonwealth's Attorney, and Board of Supervisors for District 1, District 2, District 3 and District 4.
- 2. And for the transaction of such other business as may properly come before the party canvass.

All legal and qualified voters of Wise County and the City of Norton under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meeting, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter than renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Voters may be required to produce personal identification such as a valid photo ID that is acceptable for voting purposes in order to participate.

### **FILING REQUIREMENTS**

Candidates for election for Sheriff, Clerk of Circuit Court, Commissioner of Revenue, Treasurer, Commonwealth's Attorney, and Board of Supervisors for District 1, District 2, District 3 and District 4 shall file a written statement (prefile form) by mail or in person to Kimberly Mullins, PO Box 970, Norton VA 24273, or in person at 538 Park Ave NW, Norton VA 24273, which must be received not later than March 23<sup>th</sup>, 2023 at 5:00PM and accompanied by any fees required. Postmarks will not govern.
