## Party Canvass

# of the Warren County Republican Committee of the Republican Party of Virginia

As Chairman of the Warren County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Robert Hupman, do hereby issue this call for a Party Canvass to be held at the North Warren Volunteer Fire & Rescue, 89 Rockland Rd., Front Royal, Virginia, 22630 from 2:00 PM until 7:00 PM local time on Friday, May 5, 2023. Those wishing to vote in the Party Canvass must be in line no later than 7:00 PM local time. The purpose of the Party Canvass shall be to:

- 1. Nominate a Republican candidate for each of the following Warren County Constitutional Offices for the General Election to be held on November 7, 2023:
  - a. Clerk of the Circuit Court
  - b. Commissioner of Revenue
  - c. Commonwealth Attorney
  - d. Sheriff
  - e. Treasurer
- 2. Nominate a Republican candidate for each of the following Warren County Board of Supervisor districts for the General Election to be held on November 7, 2023:
  - a. North River District
  - b. South River District
  - c. Shenandoah District

#### Qualifications for Participation

All legal and qualified voters of Warren County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. All voters for the Party Canvass must not have supported a candidate in opposition to a Republican nominee as defined in Article I of the Republican Party of Virginia Plan of Organization for a period of four (4) years. Additionally, except as described in the Republican Party Plan of Organization, all voters must not have participated in the nomination process of a party other than the Republican Party within the last five years. By voting in the Party Canvass, voters certify that they intend to support all Republican nominees and endorsees in the next General Election that will be held on November 7, 2023.

# Filing Requirements

Candidates for the nomination or election at said canvass shall file the attached Statement of Candidacy by mail or in person, to the Warren County Republican Committee Chairman, Robert Hupman, PO Box 2020, Front Royal, VA 22630 which must be received not later than 5:00 PM, March 12, 2023. The written statement must include the candidate's full name, address, and office to which the candidate is seeking nomination or election. If not more than the number of persons to be elected to each office shall file for each office, then such properly filed persons shall be declared nominated by acclamation or elected as the case may be, and no canvass will be held for such purpose.

#### Registration Fee

Candidates wishing to seek the Republican nomination for any Constitutional Office must pay a non-refundable registration fee of Five Hundred Dollars (\$500.00). Candidates wishing to seek the Republican nomination for any Board of Supervisor Office must pay a non-refundable registration fee of Two Hundred and Fifty Dollars (\$250.00). There is no fee to vote at the Warren County Republican Committee Party Canvass.
