

CALL FOR MASS MEETING

Adopted January 22, 2024

As Chairman of the Colonial Heights Republican Committee (CHRC) of the Republican Party and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Zachary Wood, do hereby issue this call for a Mass Meeting to be held at Life Christian Academy (1221 Boulevard, Colonial Heights, VA 23834), or its alternative site, starting at 7:00 PM local time, with registration beginning at 6:30 p.m., on Monday, February 26, 2024, for the following purposes:

- A) Electing a Unit Chairman;
- B) Electing members of the Colonial Heights Republican Committee;
- C) Electing 220 Delegates and an equal number of Alternates to the Fourth District Republican Convention, to be held on Saturday, May 4, 2024, beginning at 10:00 a.m., for the purpose of electing a chairman; three members of the State Central Committee for a term of four years; selecting a Republican candidate for Elector for President and Vice President of the United States for the election held on November 5, 2024, and; for the transaction of any other business that may properly come before the body. Colonial Heights is entitled to forty four (44) Delegate votes; and
- D) Electing 220 Delegates and an equal number of Alternates to the State Republican Convention, to be held on Friday May 31-Saturday, June 1, 2024 for the purpose of electing a state chairman chairman; electing a National Committeeman and National Committeewoman; Selecting two Electors At-Large to be voted for in the presidential election on November 5, 2024, and; for the transaction of any other business that may properly come before the body. Colonial Heights is entitled to forty four (44) Delegate votes; and
- E) For the transaction of such other business as may properly come before the mass meeting.

QUALIFICATIONS FOR PARTICIPATION

All legal and qualified voters of Colonial Heights under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting, either orally or in writing as may be required, their intent to support all of its nominees for public office in the

ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

FILING REQUIREMENTS

Candidates for election at said mass meeting may complete the pre-file form available online at www.colonialheightsgop.com. To be considered for election as chair at said Mass Meeting, the form must be completed and returned with a \$100 nonrefundable filing fee to treasurer Teresa Cherry by mail (204 Battery Pl, Colonial Heights, VA 23834) by Friday, February 2, 2024 at 5:00 PM local time. Postmarks shall not govern. Mass meeting attendees may mail the form to 414 Crescent Ave, Colonial Heights, VA 23834 by Friday, February 23, 2024 or brought to the Mass Meeting on Monday, February 26, 2024.

In the event the number of candidates properly filed does not exceed the number of Delegates to be elected, those candidates shall be deemed elected and the Mass Meeting canceled.

CALL REVISIONS

If necessary, the committee chairman may revise the issued call in order to make technical or conforming changes. All changes should be promptly shared with the committee.

REGISTRATION FEE

A \$5 voluntary fee may be collected from mass meeting participants.
