

## **OFFICIAL CALL**

## **Party Canvass**

## ORANGE COUNTY REPUBLICAN COMMITTEE

As Chairman of the Orange County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Kenneth Wyvill, do hereby issue this call for a Party Canvass to be held at Lafayette Station, 26322 Constitution Hwy, Rhoadesville, VA 22542 on March 9, 2024 starting at 10:00am and ending at 1pm for the following purposes:

**A. Electing** a Chairman of the Orange County Republican Committee for a term of 2 years or until his successor shall be elected.

**B. Electing up to Four Hundred Sixty** (460) **Delegates** to the 7<sup>th</sup> Congressional District Convention on March 23, 2024.

#### Who will:

- 1. **Elect** a Chairman for the 7<sup>th</sup> Congressional District.
- 2. Elect Three (3) State Central Committee members from the 7<sup>th</sup> Congressional District
- 3. Nominate one (1) Elector for the November 5, 2024, Presidential Election

**C. Elect up to Four Hundred Sixty** (460) **Delegates** to the RPV State Convention on May 31-June 1, 2024.

Who will:

- 1. Elect a State Republican Party Chairman
- 2. Select two (2) Electors At Large for the November 5, 2024, Presidential Election.
- 3. Nominate a National Committeeman and a National Committeewoman.

#### Registration

- A. Registration will begin at 9:30am local time.
- B. Registration and voting will close at 1:00pm.
- C. No proxies will be allowed.

D. Any person in line at 1:00pm will be issued a numbered pass and registered in numerical order.

- E. People arriving after 1:00pm will not be allowed to register or vote.
- F. All participants shall present a government issued photo ID at the time of registration.

G. If only one person is properly filed for Chairman, that person will be declared elected and if the number of candidates filed for Delegates is equal to or less than the allotment of 460 for each Convention, they will be declared elected, and the Party Canvas. will be cancelled.

#### **Qualification for Participation**

All legal and qualified voters of Orange County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing encompassing there, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

#### **Filing Requirements**

Candidates for the election shall file a written statement by mail or in person to Kenneth Wyvill, 16401 Grasty Lane, Orange, VA 22960, which must be received not later than 5:00pm on February 14, 2024. Postmarks will not govern.

**Candidate Registration Fee for Chairman:** There will be a \$250 registration for each candidate for Chairman payable to OCRC.

District 7 Delegate Registration Fee will be \$5.00 payable to OCRC.

State Delegate Registration Fee will be \$45 payable to OCRC.
