

OFFICIAL CALL
Mass Meeting
of the
Middlesex County Republican Committee (MCRC)
of the Republican Party of Virginia

As Chairman of the Middlesex County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, John D. Hooper, do hereby issue this Call for a Mass Meeting to be held at Cook's Corner Office Complex, 2693 General Puller Hwy, Saluda, VA, starting at 7:00 PM on Thursday, February 15, 2024, for the following purposes:

- A) Electing a Unit Chairman;
- B) Electing members of the Unit Committee as follows: Saluda – 1, Urbanna – 2, New Market – 4, Church View – 3, Harmony Village – 2, Wilton – 4, and At Large – 4;
- C) Electing up to 160 Delegates and an equal number of Alternates to the State Convention, to be held on May 31, 2024, at the Hampton Roads Convention Center, beginning at 2:30 p.m. for the purposes of a) electing a State Chairman, b) electing a National Committeeman and National Committeewoman, c) nominating two (2) Electors At-Large to be voted for in the presidential election on November 5, 2024, and d) for the transaction of such other business as may properly come before the Convention. Each unit is entitled to one (1) Delegate Vote per two hundred fifty (250) Republican votes for Governor and President at their last election, so that Middlesex County is entitled to thirty-two (32) Delegate Votes;
- D) Electing up to 160 Delegates and an equal number of Alternates to the 1st District Convention, to be held on May 4, 2024, at the King William High School, beginning at 10:00 a.m. for the purposes of a) electing a District Chairman, b) electing three (3) Members of the State Central Committee of the Republican Party of Virginia, c) nominating one (1) Elector to be voted for in the presidential election on November 5, 2024, and d) for the transaction of such other business as may properly come before the Convention. Each unit is entitled to one (1) Delegate Vote per two hundred fifty (250) Republican votes for Governor and President at their last election, so that Middlesex County is entitled to thirty-two (32) Delegate Votes; and
- E) For the transaction of such other business as may properly come before the Mass Meeting.

Qualifications for Participation

All legal and qualified Voters of Middlesex County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election Districts.

Registration Fee

There will be **no Registration Fee** to participate in this Mass Meeting.
