Candidates for the above elections must file this fully executed official Filing Form with the appropriate fee(s) by U.S. mail to the **New Kent County Republican Committee, P.O. Box 831, Quinton VA 23141** or by hand delivery to Heather Mae Donbrosky, Recording Secretary at 7284 Cress Ter, New Kent VA 23124, **NO LATER THAN 5:00 PM ON FRIDAY, MARCH 1st, 2024. FAX OR EMAIL SUBMISSIONS WILL NOT BE ACCEPTED.** Illegible, incomplete, or invalid filings, and any altered or changed reproductions of the Official Filing Form, will be subject to rejection, and accompanying fees will be deemed contributions to NKCRC. Each application must be accompanied by a separate check or money order from the applicant for the Total Fees calculated above. Grouping of Filing Forms with one payment will not be accepted.
