Mass Meeting

of the Northumberland County Committee of the Republican Party of Virginia

As Chairman of the Northumberland County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Marion Cockrell, do hereby issue this call for a Mass Meeting to be held at the Women's Club of Northumberland County, 2928 Northumberland Hwy, Lottsburg VA 22511-2720, at 7:00 PM on March 13, with registration beginning at 6:30 PM, for the following purposes:

- a) Electing a Unit Chairman;
- b) Electing Members of the Unit Committee;
- c) Electing up to one hundred seventy-five (175) Delegates and an equal number of Alternates to the 1st Congressional District Convention to be held at King William High School starting at 10:00 AM on Saturday, May 4, 2024, with registration beginning at 8:00 AM, for the following purposes:
 - Electing a District Chairman;
 - Electing three (3) Members of the State Central Committee of the Republican Party of Virginia;
 - Nominating one (1) Elector to be voted for in the presidential election on November 5, 2024; and
 - For the transaction of such other business as may properly come before the Convention.
 - Each unit is entitled to one (1) Delegate Vote per two hundred fifty (250) Republican votes for Governor and President at their last election, so that Northumberland County is entitled to thirty-five (35) Delegate Votes.
- d) Electing up to one hundred seventy-five (175) Delegates and an equal number of Alternates to the State Convention to be held at the Hampton Roads Convention Center starting at 2:30 PM on Friday, May 31, 2024, and 10:00 AM on Saturday, June 1, for the following purposes:
 - Electing a State Chairman;
 - Electing a National Committeeman and a National Committeewoman;
 - Nominating two (2) Electors At-Large to be voted for in the presidential election on November 5, 2024; and
 - For the transaction of such other business as may properly come before the Convention.
 - Each unit is entitled to one (1) Delegate Vote per two hundred fifty (250) Republican votes for Governor and President at their last election, so that Northumberland County is entitled to thirty-five (35) Delegate Votes.
- e) For the transaction of such other business as may properly come before the Mass Meeting.

Qualifications for Participation

All legal and qualified voters of Northumberland County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or

in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election as Unit Chairman shall file a written statement, along with a \$25 filing fee, by mail or in person, to Marion Cockrell, 83 Golf Ln, Burgess VA 22432-2108, which must be received not later than 5:00 PM on March 8, 2024. Postmarks do not govern.

Candidates for election as a Member of the Northumberland County Republican Committee must submit the filing form found on the Republican Party of Virginia website, virginia.gop, which states intent to seek election to the Committee. All forms must be received no later than 5:00 PM on March 8, 2024, either in person or by mail, to Marion Cockrell, 83 Golf Ln, Burgess VA 22432-2108. Postmarks do not govern.

Candidates for election as Delegate (or Alternate) to the May 4, 2024, 1st District Convention and/or Delegate (or Alternate) and the State Convention to be held May 31 and June 1, 2024, must submit the filing form found on the Republican Party of Virginia website, virginia gop, which states intent to seek election for each specific position. All statements, along with applicable mandatory filing fees of \$10 for the 1st District Convention and/or \$45 for the State Convention, must be received not later than 5:00 PM on March 8, 2024, either in person or by mail, to Marion Cockrell, 83 Golf Ln, Burgess VA 22432-2108. Postmarks do not govern.

There will be no registration fee to participate in this mass meeting.
